Notice of Complaint Resolution Procedure

If a recipient has a complaint or grievance, he/she should proceed to contact the following people or agencies in the order listed below, as needed. A response will be given to the recipient within one week, whenever practical, and at each step of this procedure. Responses to emergency or crisis situations will be given as soon as possible, depending upon the situation.

- 1. Contact the primary therapist, nurse, or case manager to discuss the complaint.
- 2. If this fails to resolve the complaint, contact the Program Director:

 - b. PROS: Foundations for Change, 203 Laurens Street, Olean, NY 14760 (716-373-8080)
- 3. If this fails to resolve the complaint, contact the Director of Cattaraugus County Department of Community Services/Local Governmental Unit, County Building, 1 Leo Moss Drive, Suite 4308, Olean, NY 14760 (716-373-8040).
- 4. If this fails to resolve the complaint, contact the Western New York Field Office of Mental Health (OMH), 737 Delaware Avenue, Suite 200, Buffalo, NY 14209 (716- 533-4075.). The Commissioner may at his or her discretion, call a conference of all parties to review the objection. The OMH Commissioner's decision is the final administrative remedy available to you.
- 5. You may appeal the Commissioner's decision in accordance with the provisions of Article 78 of the Civil Practices Laws and Rules. It is recommended you contact your attorney if you wish to pursue such an appeal.
