**DIRECTIVE 1-2020 – AMENDMENT NO. 2
CATTARAUGUS COUNTY, NEW YORK**

I, Howard V. VanRensselaer, Chairman, Cattaraugus County Legislature, in accordance with a declaration of a State of Emergency issued on March 15, 2020 and subsequent extensions thereto and pursuant to Section 25 of the State Executive Law, hereby issue the following directive(s):

The Department of Motor Vehicles Office in Delevan will remain closed to the public.

The Department of Motor Vehicles Offices in Olean and Little Valley will be open to the public. However, there is a new appointment system in place for customers of the Department of Motor Vehicles Offices in Olean and Little Valley. Appointments will be given priority over walk-in customers.

All customers are required to wear a face-covering and must follow the social distancing guides provided.

No permit testing will be performed until further notice.

This Directive is effective June 22, 2020 and shall remain in effect until rescinded or until the State of Emergency expires, whichever occurs first.
