APPROVING AMENDED CONTRACT BETWEEN CATTARAUGUS COUNTY COMMUNITY SERVICES BOARD AND COUNCIL ON ADDICTION RECOVERY SERVICES, INC. FOR SUBSTANCE ABUSE PROGRAM FUNDS AND ADJUSTING VARIOUS APPROPRIATION AND REVENUE ACCOUNTS (Department of Community Services)

Pursuant to Articles 1, 19, 23 and 25 of the Mental Hygiene Law and Sections 363, 366 and 450 of the County Law.

I. WHEREAS, Act 632-2018, as amended by Acts 121-2019 and 358-2019, authorized approval of a contract with Council on Addiction Recovery Services, Inc., for the provision of a substance abuse program in the County, the term of which expires December 31, 2019, and

II. WHEREAS, New York State has awarded additional startup funds for a new Part 820 residential program associated with the Rapid Capital Project in Cattaraugus County in an amount of \$205,051.00 for the period August 1, 2019 through December 31, 2019, and

III. WHEREAS, an amended contract is necessary in order to accept, and receive, the aforementioned additional startup funding, and

IV. WHEREAS, the additional Part 820 residential program is 100% state funded (total contract is 21.3% federal (CFDA #93.959), 76.9% state and 1.8% county funded), and

V. WHEREAS, various appropriation and revenue accounts must be adjusted in order to accommodate the aforementioned funding, now, therefore, be it

I. RESOLVED, that the Chair of the Legislature be, and hereby is, authorized and directed to execute an amended contract between the Cattaraugus County Community Services Board and the Council on Addiction Recovery Services, Inc., to signify the County's approval, for the provision of the above-described services, to amend the contract which commenced January 1, 2019 and terminates December 31, 2019, according to the above-described terms, and be it further

SUPPORTING ADOPTION OF SENATE BILL S.428-A AND ASSEMBLY BILL A.47-A BY NEW YORK STATE LEGISLATURE REGARDING THE PROHIBITION OF THE SALE AND DISTRIBUTION OF FLAVORED E-LIQUID FOR USE IN E-CIGARETTES

Pursuant to Section 153 of the County Law.

WHEREAS, Senate Bill S.428-A and Assembly Bill A.47-A have been introduced in the State Legislature to ١. prohibit the sale and distribution of flavored "e-liquids" for use in electronic cigarettes and electronic cigarettes containing such flavoring, and

WHEREAS, many e-cigarette and liquid nicotine products come in flavors that are attractive to young 11. people, such as cherry, fruit punch, chocolate and cola, and

III. WHEREAS, recent studies by the Food and Drug Administration and the Centers for Disease Control and Prevention show a marked increase in the use of e-cigarettes and liquid nicotine by middle and high-school students, and

IV. WHEREAS, in the past year, the percentage of middle school students using e-cigarettes has increased by 50%, with use by high school students increasing by 80%, and

WHEREAS, the most commonly cited reasons for using e-cigarettes among both youth and young adults V. are curiosity, fruit and candy flavorings offered by liquid nicotine manufacturers and the low-perceived harm compared to other tobacco products, and

VI. WHEREAS, limiting liquid nicotine to tobacco flavor available for purchase would reduce children's interest in using these products while allowing adults the option to continuing e-cigarettes as a replacement for traditional tobacco products or for smoking cessation purposes, and

VII. WHEREAS, the Cattaraugus County Legislature finds that it is necessary to protect and promote the public health, safety and welfare of the youth and young adults residing in Cattaraugus County, now, therefore, be it
