Pursuant to Section 10 of the Municipal Home Rule Law.

A LOCAL LAW ESTABLISHING FEES FOR CATTARAUGUS COUNTY HEALTH DEPARTMENT SERVICES AND REPEALING LOCAL LAW NUMBER 3-2017 (INTRO NUMBER 1-2017)

BE IT ENACTED by the County Legislature of the County of Cattaraugus as follows:

SECTION 1. Legislative Intent. It is the intent of this Local Law to revise the fee schedule currently in effect for

certain services provided by the Cattaraugus County Health Department.

SECTION 2. Fee Schedule. Effective May 1, 2020, the following fees shall be charged by the Cattaraugus County Health Department.

<u>SECTION 3.</u> <u>Severability.</u> If any provision of this Local Law shall be adjudged by any court of competent jurisdiction to be invalid, then such adjudication, shall not effect, impair or invalidate the remainder thereof, but shall be confined in its operation to the particular provision directly involved in the controversy in which such judgment shall have been rendered.

SECTION 4. Repeal Local Law Number 3-2017, as amended. Local Law Number 3-2017 (Intro Number 1-2017), is hereby repealed.

SECTION 5. Effective Date. This Local Law shall take effect immediately.
