# LOCAL LAW NUMBER 4 - 2022 COUNTY OF CATTARAUGUS, NEW YORK

Pursuant to Sections 10 and 24 of the Municipal Home Rule Law and Sections 201 and 205 of the County Law.

#### A LOCAL LAW ESTABLISHING SALARIES FOR CERTAIN COUNTY OFFICERS

BE IT ENACTED by the County Legislature of the County of Cattaraugus as follows:

<u>SECTION 1.</u> Legislative Intent. It is the intent of this Local Law to provide an equitable salary structure for certain elected or appointed County Officers who serve through either fixed or indefinite terms.

SECTION 2. Compensation Based on Salary Table. The Cattaraugus County Legislature adopted Act 294-2022, which established a Salary Table for certain elected or appointed County Officers. Effective January 1, 2022, the County Officers listed below shall receive compensation based upon such Salary Table:

SECTION 3. Salary for Coroners. Effective January 1, 2022, County Coroners shall receive a salary of \$13,876.89.

<u>SECTION 4.</u> Supercession. All local laws and resolutions of the Cattaraugus County Legislature, including without limitation Local Law Number 2-2021 (Intro Number 2-2021) and Act No. 77-2021, to the extent that the same are inconsistent with this local law, are hereby superseded.

<u>SECTION 5.</u> <u>Effective Date.</u> This Local Law is subject to permissive referendum in accordance with Section 24 of the Municipal Home Rule Law.

# LOCAL LAW NUMBER 5 - 2022 COUNTY OF CATTARAUGUS, NEW YORK

Pursuant to Section 10 of the Municipal Home Rule Law.

# A LOCAL LAW AUTHORIZING DEPUTY SHERIFFS EMPLOYED BY THE COUNTY OF CATTARAUGUS TO RESIDE IN CATTARAUGUS COUNTY OR ANY ADJOINING COUNTY WITHIN NEW YORK STATE

BE IT ENACTED, by the County Legislature of the County of Cattaraugus as follows:

Section 1. Intent. It is the intent of this local law to authorize Deputy Sheriffs, who are employed by the County of Cattaraugus, to reside in Cattaraugus County or any adjoining County within New York State.

Section 2. Residency of Deputy Sheriffs. In the County of Cattaraugus, the provisions of Section 3 of the New York State Public Officers Law requiring a person to be a resident of the political subdivision or municipal corporation of the State for which such person shall be chosen or within which such person's official functions are required to be exercised, shall not prevent a person from holding the office of Deputy Sheriff in Cattaraugus County, provided, however, that such person performing the duties and functions of Deputy Sheriff resides in Cattaraugus County or any adjoining county within New York State, unless otherwise provided by an act of the State Legislature.

<u>Section 3.</u> <u>Severability.</u> If any provision of this Local Law shall be adjudged by any court of competent jurisdiction to be invalid, then such adjudication shall not effect, impair or invalidate the remainder thereof, but shall be confined in its operation to the particular provision directly involved in the controversy in which such judgment shall have been rendered.

<u>Section 4.</u> Effective Date. This Local Law shall take effect immediately upon filing with the Secretary of State in accordance with Section 27 of the Municipal Home Rule Law.

# LOCAL LAW NUMBER 6 - 2022 COUNTY OF CATTARAUGUS, NEW YORK

Pursuant to Sections 10(1)(ii)(a)(13) and 23 of the Municipal Home Rule Law.

A LOCAL LAW IN RELATION TO THE REAPPORTIONMENT OF THE COUNTY LEGISLATIVE DISTRICTS OF THE COUNTY OF CATTARAUGUS, REDUCING THE NUMBER OF COUNTY LEGISLATORS FROM 17 TO 15, AMENDING LOCAL LAW NUMBER 6-1968 (INTRO NUMBER 11-1968) ENTITLED "A LOCAL LAW ESTABLISHING A COUNTY LEGISLATURE FOR CATTARAUGUS COUNTY AS REQUIRED BY ORDER OF THE NEW YORK STATE SUPREME COURT" AND REPEALING LOCAL LAW NUMBER 6-2011 (INTRO NUMBER 6-2011)

BE IT ENACTED by the County Legislature of the County of Cattaraugus as follows:

SECTION 1. Legislative Intent. It is the intent of this Local Law to amend Local Law Number 6-1968 (Intro Number 11-1968), entitled "A Local Law Establishing a County Legislature for Cattaraugus County as required by Order of the New York State Supreme Court", adopted August 14, 1968 by the Cattaraugus County Board of Supervisors and to repeal Local Law Number 6-2011 (Intro Number 6-2011).

SECTION 2. Amendment of Local Law Number 6-1968. Effective for the general election in November 2023, for terms to commence January 1, 2024 and thereafter, Local Law Number 6-1968 (Intro Number 11-1968), is hereby amended by deleting Section 2 thereof and replacing such section with the following: "SECTION 2. Legislative Districts. For the purpose of electing County Legislators, Cattaraugus County shall be divided into five (5) districts, described as follows and further described on the map annexed hereto, each of which shall be represented by the number of legislators set forth herein:

SECTION 3. Legislative Districts Continued. The eight (8) legislative districts as previously bounded and described by Local Law Number 6-2011 (Intro Number 6-2011) shall continue in existence for the limited purpose of continuing the legislators in office presently elected for the term ending December 31, 2023, from such districts, as well as any legislators appointed to fill vacancies as defined in Section 30 of the Public Officers' Law in such districts and/or elected to fill the unexpired terms of legislators in such districts, and shall cease to exist as such at the time all of the terms and provisions of this local law become effective.

SECTION 4. Construction. This local law shall be liberally construed to achieve its objectives and purposes. If the districts described herein do not carry out the purposes hereof because of unintentional omissions, duplications, overlapping areas, erroneous nomenclature, lack of adequate maps or descriptions or descriptions of political subdivisions, wards, or other divisions thereof, or changes of public places, alteration of the boundary or courses of waters or waterways, accretion or other changes in shorelines, the County Clerk, at the request of any person or candidate aggrieved thereby, shall, by order, correct such omissions, overlaps, erroneous nomenclature or other defects in the description of districts so as to accomplish the purposes and objectives of this local law.


SECTION 5. Repeal of Local Law Number 6-2011 (Intro Number 6-2011). Local Law Number 6-2011 (Intro Number 6-2011) is hereby repealed, effective at the time set forth in Section 3, supra.

<u>SECTION 6.</u> Local Law No. 6-1968. All other provisions of Local Law Number 6-1968 (Intro Number 11-1968) not otherwise amended herein shall remain in full force and effect.

<u>SECTION 7.</u> Severability. If any provision of this local law shall be adjudged by any court of competent jurisdiction to be invalid, such adjudication shall not affect, impair or invalidate the remainder thereof, but shall be confined in its operation to the particular provision directly involved in the controversy in which such judgment shall have been rendered.

<u>SECTION 8.</u> Effective Date. This local law shall take effect only after it has been approved by the affirmative vote of the majority of the qualified electors of Cattaraugus County voting on a proposition for its approval submitted at a general election to be held November 8, 2022, in the County of Cattaraugus.
