**AUTHORIZING THE CHAIR TO EXECUTE SUPPLEMENTAL AGREEMENT NO. 1  
WITH NYSDOT AND AUTHORIZING CATTARAUGUS COUNTY TO PARTICIPATE IN  
FEDERAL-AID PROJECT ADMINISTERED BY THE NYSDOT AND  
ADJUSTING VARIOUS APPROPRIATION AND REVENUE ACCOUNTS  
(Bridge Painting Contract #D040673-Department of Public Works)**

Pursuant to Title 23 U.S. Code and  
Sections 363, 366 and 450 of the County Law.

- I. WHEREAS, Act 317-2022 authorized a Federal Aid Local Project Agreement for the 2022 Cattaraugus County Bridge Painting Project: four (4) bridges located within the Towns of Leon, Little Valley and Freedom in Cattaraugus County, BIN 3321630, 3322260, 3322380, and 3322180 (the "Project"), and
- II. WHEREAS, the County desires to advance the above Project by increasing the costs of the Construction & Construction Inspection phase of the Project, PIN 5763.68, and adding approved allocated Marchiselli Match funds, for an amount of \$75,000.00, and a total Project amount of \$635,000.00, and
- III. WHEREAS, various appropriation and revenue accounts must be adjusted to cover the aforementioned \$75,000.00 increase, now, therefore, be it
- I. RESOLVED, that the Cattaraugus County Legislature hereby approves the above-described Project, and be it further
- II. RESOLVED, that the Cattaraugus County Legislature hereby authorizes the County of Cattaraugus to pay in the first instance 100% of the federal and non-federal shares of the cost of the Construction & Construction Inspection phase of the Project, or portions thereof, and be it further
- III. RESOLVED, that the sum of \$75,000.00 is hereby appropriated, in addition to \$560,000.00 previously appropriated and made available to cover the cost of participation in the above phase of the Project, and be it further
- IV. RESOLVED, that in the event the amount required to pay the full federal and non-federal shares of the cost of the Project's Construction & Construction Inspection phase exceeds the amount appropriated above, the County of Cattaraugus shall convene its Legislature as soon as possible to appropriate said excess amount immediately upon the notification by the NYSDOT thereof, and be it further
- V. RESOLVED, that the Chair of the Legislature be, and hereby is, authorized and directed to execute all necessary documents, on behalf of Cattaraugus County, with the NYSDOT in connection with the advancement or approval of the Project and providing for the administration of the Project and the municipality's first instance funding of Project costs and permanent funding of the local share of federal-aid and state-aid eligible Project costs and all Project costs within appropriations therefor that are not so eligible, and be it further

VI. RESOLVED, that a certified copy of this resolution be filed with the New York State Commissioner of Transportation by attaching it to any necessary agreement in connection with the Project, and be it further

VII. RESOLVED, that this Resolution shall take effect immediately, and be it further

VIII. RESOLVED, that the County Administrator is hereby directed to make the following budgetary changes:

I. WHEREAS, Act 462-2021 authorized a contract with SJB Services, Inc., 5167 South Park Avenue, Hamburg, New York 14075, for the provision of soil boring services for various bridge projects, the term of which expires December 31, 2022, and

II. WHEREAS, the County Department of Public Works is desirous of obtaining soil boring, material testing, deck coring and geotechnical engineering services for various 2023 projects, and

III. WHEREAS, SJB Services, Inc., has agreed to perform soil boring, material testing, deck coring and geotechnical engineering services for various 2023 projects on an as-needed basis, for an amount not to exceed \$75,000.00, to be paid on a percent-of-completion basis, as invoiced, now, therefore, be it

I. Single Person	\$80.00/night
Single Parent Family	\$80.00/night plus \$20.00 per night for each additional child
2 Parent Households	\$100.00/night plus \$20.00 per night for each additional child
After 30 Days	\$55.00 per night for single adults and couples plus \$15.00 per night per child

Hotel reimbursement in emergency situations at a reasonable rate for a maximum of 3 nights (Only if a DSS application was completed by shelter staff with the individual at the time of hotel placement),
