**LOCAL LAW NUMBER 7 - 2022
COUNTY OF CATTARAUGUS, NEW YORK**

Pursuant to Section 10 of the Municipal Home Rule Law.

**A LOCAL LAW ESTABLISHING FEE SCHEDULE
FOR ONOVILLE MARINA BOATING AND CAMPING ACTIVITIES**

BE IT ENACTED by the County Legislature of the County of Cattaraugus as follows:

SECTION 1. Legislative Intent. It is the intent of this Local Law to establish a fee schedule for the Onoville Marina boating and camping activities.

SECTION 2. Onoville Marina Fees. Effective January 1, 2023, the following fees shall be charged by the Cattaraugus County Onoville Marina for boating and camping activities:

SECTION 3. Severability. If any provision of this Local Law shall be adjudged by any court of competent jurisdiction to be invalid, then such adjudication, shall not effect, impair or invalidate the remainder thereof, but shall be confined in its operation to the particular provision directly involved in the controversy in which such judgment shall have been rendered.

SECTION 4. Effect on Prior Legislation. This Local Law shall supersede Local Law Number 10-2021 (Intro No. 10-2021) which established a fee schedule for Onoville Marina boating and camping activities, and became effective January 1, 2022.

SECTION 5. Effective Date. This Local Law shall take effect January 1, 2023.

I. WHEREAS, Act 537-2021, as amended by Act 288-2022, authorized a contract with CPL: Architecture-Engineering-Planning, 26 Mississippi Street, #300, Buffalo, New York 14203, for the provision of architectural and engineering services for the renovation of ~~four (4)~~ **five (5)** separate locations in the Olean County Office Facility (Community Services, Department of Social Services, Information Services, **Buildings and Grounds** and County Attorney's Office), to improve the overall use of space, the term of which expires December 31, 2022, and

II. WHEREAS, it is necessary to extend the term of the aforementioned contract to December 31, 2023, in order to complete the aforementioned project, at no additional cost to the County, now, therefore, be it

I. RESOLVED, that the Chair of the Legislature be, and hereby is, authorized and directed to execute a contract extension, on behalf of Cattaraugus County, with CPL: Architecture-Engineering-Planning, for the provision of the above-described architectural and engineering services, to amend the term of the contract which commenced January 3, 2022 to terminate December 31, 2023, according to the above-described terms.

I. WHEREAS, Act 562-2021 authorized a contract with Gowanda Central School District for the provision of mental health services through the placement of a social worker in the school, the term of which expires December 31, 2022, and

II. WHEREAS, the County Department of Community Services is desirous of continuing the placement of a social worker in the Gowanda Central School District, and

III. WHEREAS, a contract is necessary with the Gowanda Central School District to outline the mental health services to be provided by the County's mental health clinician, at no cost to the County, and

IV. WHEREAS, the Gowanda Central School District shall provide an office, a family meeting room, a phone line and furniture, ~~as well as a family support staff to work in conjunction with the County staff to meet the needs of families,~~ and special equipment for the County's mental health clinician at no cost to the County, now, therefore, be it

I. RESOLVED, that the Chair of the Legislature be, and hereby is, authorized and directed to execute a contract, between the Cattaraugus County Community Services Board and the Gowanda Central School District, to signify the County's approval, for the provision of the above-described services, for a term commencing January 1, 2023 and terminating December 31, 2023, according to the above-described terms.
