LOCAL LAW NUMBER 7 - 2019 COUNTY OF CATTARAUGUS, NEW YORK

A LOCAL LAW REQUIRING CATTARAUGUS COUNTY CLERK TO OBTAIN COUNTER SIGNATURES FROM CITY OF OLEAN PRIOR TO RECORDING OF DEEDS

Pursuant to Section 10 of the General Municipal Law.

<u>Section 1.</u> Legislative Intent. It is the intent of this local law to require the Cattaraugus County Clerk to obtain a counter signature from the City of Olean on each and every deed conveying real property located within the City of Olean.

<u>Section 2.</u> County Clerk to Obtain Counter Signature. The Cattaraugus County Clerk shall not record any deed, transfer or conveyance of land for property located within the City of Olean, unless such deed contains a counter signature from the City of Olean, on the condition that the City of Olean shall waive its fee for the counter-signature of deeds by which the County Treasurer, as grantor, conveys and such real property.

<u>Section 3.</u> <u>Severability.</u> If any clause, sentence, paragraph, subdivision, section, or part of this Local Law or the application thereof to any person, individual, corporation, firm, partnership, or business shall be adjudged by any court of competent jurisdiction to be invalid or unconstitutional, such order or judgment shall not effect, impair or invalidate the remainder thereof but shall be confined in its operation to the clause, sentence, paragraph, subdivision, section, or part of this law, or in its specific application.

<u>Section 4.</u> Effective Date. This Local Law shall become effective as provided in Municipal Home Rule Law Section 27.

AUTHORIZING PUBLIC HEARING ON LOCAL LAW NUMBER 7 - 2019

Pursuant to Section 20 of the Municipal Home Rule Law.

I. WHEREAS, there has been duly presented and introduced at a meeting of this Legislature held on May 8, 2019, a proposed Local Law entitled "A Local Law Requiring Cattaraugus County Clerk to Obtain Counter Signatures from City of Olean Prior to Recording of Deeds", and

II. WHEREAS, no local law shall be adopted until a public hearing thereon has been had by the Cattaraugus County Legislature upon at least five (5) days' notice, now, therefore, be it

I. RESOLVED, that a public hearing shall be held on the proposed Local Law by this County Legislature on the 22nd day of May, 2019, at 4:01 p.m. at the Legislature's Chambers, County Office Building, 303 Court Street, Little Valley, New York, and that at least five (5) days' notice of such hearing shall be given by the Clerk by the due posting thereof upon the bulletin board of each County Court House within the County and by publishing such notice at least once in the official newspapers of the County.
