2.1 General Municipal Law Section 239 (I) & (m) Referrals

2.1 a. Town of Ellicottville - Special Use Permit and Site Plan Review Portion of Holiday Valley at 6557 Holiday Valley Road

- •The applicant is requesting to subdivide 5.3 acres from lands owned by Holiday Valley between Snow Pine Village and the Inn at Holiday Valley, in order to establish a "Scandinavian style spa". The spa is comprised of 6 buildings totaling 13,406 sq. ft., plus 1,265 sq. ft.. in pool and terrace area. The concept site plan includes parking for 100 vehicles along a looped drive with access off the end of the Snow Pine Village road.
- •The property is located in the High Density (HD) Residential District where a spa is allowed with a Special Use Permit from the Planning Board.

•The spa will offer limited food and beverage (warming kitchen only), massage, and a full range of hydrotherapy benefits where visitors can transition from hot installations (hot baths, saunas, steam room) to cold installations (cold baths, showers) to relaxation areas (indoor relaxation rooms, outdoor seating).

2.1 b. Village of Little Valley - Special Use Permit and Site Plan Review 104/106 Rock City St.

- •Applicant (Little Valley Library) wishes to construct a parking lot adjacent to their building.
- •Parking lot will be 80' x 100' with a gravel base and blacktop. There will be a right turn only sign when exiting the lot onto Rock City St.
- •They have obtained a NYS DOT work permit
- •Did not see any mention of stormwater control for the site. Parking lot will drain to Rock City St. and the trees on the north side of the property will remain and serve as a buffer between the property and the unnamed creek to the north.
- •Applicant should consider a porous pavement for the lot for better stormwater control.
