Details of Incident:

Following a drug investigation by the Olean Office of the Southern Tier Regional Drug Taskforce into the selling of illegal narcotics Karl Robinson (36) of 5645 Windfall Rd. Kill Buck, N.Y., Caylie Layfield (30) of Olean, N.Y., and Tyler Harding (28) of Hamburg, N.Y. were arrested Friday morning, January 18th following a search warrant executed at 5645 Windfall Rd. Kill Buck, N.Y., Cattaraugus County NY. Cattaraugus County Sheriff's office Special Response Team executed the search warrant at the residence. The search resulted in finding packaging, scales, pills, and a quarter ounce of crystal methamphetamine. The above defendants were charged with one count of criminal possession of a controlled substance ('D' Felony) and one count of criminally using drug paraphernalia ('A' Misdemeanor), with multiple charges pending and further arrests to be made.

The above defendants were arraigned at the Town of Allegany court and Layfield and Harding remanded to jail held on 5000.00 cash bail, Robinson was remanded to jail with no bail.
