Following an investigation of a complaint from the Cattaraugus County Department of Social Services, the suspects were arrested for 5 Counts of Offering a False Instrument for Filing in the First Degree (E Felony). The female was also arrested for Misuse of Food Stamps (Misdemeanor). The charges were the result of the suspects submitting documents to the Department of Social Services that contained false information. The Misuse of Food Stamps charge resulted from the suspect selling food that was purchased with her food stamps.
